Supply and Installation of Solar Street Lights at

the implementation of 20% EDF (Hon. Jose O.

1. The Municipality of Bay, Laguna through the 20% EDF intends to apply the sum of *One Million Nine Hundred Ninety Nine Thousand Eight Hundred Ninety Six Pesos and Fifty Centavos Only* (PHP 1,999,896.50), Delivery of labor and materials for the project Supply and Installation of Solar Street Lights at Brgy. Bitin, and Brgy. Sta. Cruz, Bay, Laguna for the implementation of 20% EDF (Hon. Jose O. Padrid), PROJECT ID. NO. I-2024-004, being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Municipality of Bay, Laguna now invites bids for the above Procurement Project. Completion of the Works is required *120 calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **BAC Secretariat Office**, and inspect the Bidding Documents at the address given below from **9:00 am to 3:00 pm, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **BAC Secretariat starting on June 11, 2024 to July 2, 2024 (9:00 am-3:00 pm)** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (PhP 5,000.00)*. The Municipality of Bay shall allow the bidder to present its proof of payment at the BAC Secretariat's Office. Payment will be made directly at Treasurer's Office from 8:00 am to 4:00 pm only.

The Municipality of Bay, Laguna, will hold a Pre-Bid Conference<sup>1</sup> on **June 18, 2024 (10:00 a.m.)** at the **Conference Hall, 2<sup>nd</sup> Floor Chipeco Building Municipality of Bay, Laguna**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through the address below on or before **July 3, 2024 (8:00a.m. P.S.T.)**. Late bids shall not be accepted.

The Municipality of Bay, Laguna reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
