**Procurement of Food Supplies to be used in
Supplemental Feeding Program of 15
Barangays in Bay, Laguna**

1. The Municipality of Bay, Laguna, through the **General Fund** intends to apply the sum of *Three Hundred Ninety Nine Thousand Nine Hundred Ninety Pesos Only (Php 399,990.00)*, *Updating of Tax Mapping with GIS database link to other departments in the Procurement of Food Supplies to be used in Supplemental Feeding Program of 15 Barangays in Bay, Laguna*, **PROJECT ID. NO. G-2024-007** being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Municipality of Bay, Laguna, now invites bids for the above Procurement Project. Delivery of the Goods is required by **15 calendar days**. Bidders should have completed, within **15 calendar days** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from **BAC Secretariat Office**, and inspect the Bidding Documents at the address given below during **9:00 am to 3:00 pm, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **BAC Secretariat starting on June 24, 2024 to July 2, 2024, (9:00 am-3:00 pm)** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos Only (Php 500.00)*. The Municipality of Bay shall allow the bidder to present its proof of payment at the BAC Secretariat's Office. Payment will be made directly at Treasurer's Office from 9:00 am to 3:00 pm only.
6. Bids must be duly received by the BAC Secretariat through the address below on or before **July 3, 2024 (8:00a.m. P.S.T.)**. Late bids shall not be accepted.


7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

The Municipality of Bay, Laguna reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
